ERC awards 400 new Starting Grants

The European Research Council (ERC) has announced that it is awarding 400 Starting Grants to young scientists and scholars across Europe totalling €628 million. Successful applicants of this call will carry out their projects at universities and research centres in 24 countries in Europe, with the highest number of projects hosted in Germany (87 grants. Denmark will host five grantees, including one at Aarhus University, where Iza Romanowska will implement "The Model City. Drivers and Mechanisms of Long-term Urban Evolution and Resilience". Outlook on potential options for the future of ERICs

The Commission has published the third Monitoring Report on the European Research Infrastructure Consortium (ERIC) Regulation. To date, the regulation has enabled the creation of 26 ERICs with at least seven more in the pipeline. The report provides details on progress and statistics. With ERICs now having 14 members on average, an overall growth in membership of older ERICs of 70% has been observed. 60% of infrastructures by the European Strategy Forum on Research Infrastructures (ESFRI) were created as ERICs. The report stresses that financial and operative sustainability remains a core challenge for ERICs.





To add to this, the <u>Tenerife declaration</u> advocates for promoting the ecosystem around research infrastructure, to ensure long-term sustainability of research infrastructures.

Every year, Denmark pays €80 million for Danish participation in nine international research infrastructures. In a new publication, a new Danish strategy for participation in international research infrastructures has been published. The publication highlights four strategic goals that have been identified with the aim of making sure Danish actors are gaining from their participation in infrastructures.

17 new projects under Soil Deal for Europe

The Commission has announced that 17 new research projects will receive €90 million of funding under the EU Mission A Soil Deal for Europe. The projects gather 314 participants from 32 countries (EU Member States, countries associated to Horizon Europe, and several non-associated countries (United Kingdom, United States, Canada and Switzerland)). The projects include universities, research institutions, SMEs, businesses, NGOs and local authorities. Aarhus Universirty is partner in the project MARVIC – "Developing and testing a framework for the design of harmonized, context-specific Monitoring, Reporting and Verification systems for soil Carbon and greenhouse gas balances by Agricultural activities". Call launch: BIODIVERSA+

BIODIVERSA+ has launched a transnational call with SSH opportunities on "Nature-Based Solutions for biodiversity, human well-being and transformative change (BiodivNBS)". This call aims to support research on biodiversity to gain a better understanding of the tipping points and trade-offs and underlying mechanisms affecting Nature-based Solutions. European Chips Act enters info force

With the official launch of the European Chips Act, aiming to ensure the EU's security of supply, resilience and technological leadership in semiconductor technologies and applications, the former Key Digital Technologies Joint Undertaking, is now officially Chips Joint Undertaking. Chips JU will start the implementation of the main part of the Chips for Europe Initiative.

The Chips Act aims to create the conditions for the development of a European industrial base in the field of semiconductors, attract investment, promote research and innovation and prepare Europe for any future chip supply crisis. The programme should mobilise €43 billion in public and private investment (€3.3 billion from the EU budget), with the objective of doubling the EU's global market share in semiconductors, from 10% now to at least 20% by 2030. 53 selected projects for EIC Pathfinder

The European Innovation Council (EIC) has selected 53 projects that will receive a total of €169.5 million to develop cutting-edge technologies. EIC Pathfinder aims to support the

EIT KIC Financial Sustainability activities are designed to help the KICs achieve autonomy while still accomplishing their missions of driving positive societal change through innovation. Results of Horizon Europe Space-related Calls

The Commission has presented the results of 2022–2023 space-related research calls for proposals under Horizon Europe. In total, €166 million will support 54 space research projects implemented by the European Health and Digital Executive Agency (HaDEA) and the EU Space Programme Agency (EUSPA). Space-related projects are expected to receive close to €1.6 billion in total during Horizon, corresponding to an average of €225 million per year. For more information, please follow this link.

UK Association to Horizon Europe

After years of in-dept discussion between the UK and EU, a final agreement for UK association to Horizon Europe has been reached. The association will begin from 2024, meaning that UK partners can participate like partners from Member State in calls within work programme 2024 and beyond. The UK will be required to contribute financially to the Horizon budget, where it is estimated that the UK will contribute almost €2.6 billion per year on average for its participation in both Horizon Europe and the Copernicus component of the

Iliana Ivanova confirmed new Commissioner for DG RTD

The European Parliament has approved the appointment of Iliana Ivanova (Bulgaria) as Commissioner for Innovation, Research, Culture, Education and Youth (DG RTD). 522 MEPs voted in favour, 27 against, 51 abstained. The appointment follows a hearing in the Industry, Research and Energy Committee and the Culture and Education Committee (ITRE) to assess Ivanova's suitability to replace Mariya Gabriel. After the hearing, both committees gave Ivanova a positive evaluation. The Guild welcomes this appointment. For more information, please follow this link.

Vestager on leave

Margrethe Vestager, the Executive Vice-President of the European Commission and Commissioner for Competition, has announced that she is running as an official candidate for the presidency of the European Investment Bank (EIB). Therefore, Vestager is on unpaid leave from her position as Commissioner. During the period of the temporary withdrawal, the responsibility for 'A Europe Fit for the digital age' has been assigned to Vice-President Věra Jourová, and the portfolio responsibility for Competition to Commissioner Didier Reynders (DG JUST). The next EIB president will take up their role in January 2024, and the choice is expected soon. For more information, please follow this link.

State of the Union by Commission President von der Leyen

President of the European Commission Ursula von der Leyen has presented her State of the Union (SOTEU) speech. Main elements related to research and innovation include the following:

- Green Deal is entering a next phase. This includes amongst others, a series of "Clean Transition Dialogues" with industry, a European Wind Power Package, and a continued focus on skills.
- Competitiveness, where labor and skills shortages present a major challenge.





- The President highlighted the importance of European sovereignty.
- President von der Leyen sees Europe in a leading role in managing the risks of digitalisation, and as the "global pioneer of citizen's rights in the digital world". Therefore, the Commission is planning a "new global framework for Al".
- A new strategic approach towards Africa is envisaged.

Denmark receives additional seat in the Parliament

The Parliament has approved the Council's decision to increase the number of seats in the Parliament for the next legislative term from 705 to 720. The Council's proposal was based on Parliament's report of June 2023, which started the process and was prompted by demographic changes in the EU since the 2019 elections. This means, that Denmark after the next election (6-9 June 2024) will have 25 seats in the Parliament. For more information, please follow this link.

Inputs for FP10

Positioning before the negotiations of the successor of Horizon Europe, the Framework Programme 10 (FP10), has started. EARTO has published its inputs on FP10 highglighting 6 strategic issues. So has The Guild, in a paper highlighting how a framework programme can best serve the needs of the European scientific community and achieve world-changing scientific breakthroughs to meet today's most pressing societal challenges. In addition to this, Allea has also published its FP10 position paper which advocates for widening scientific cooperation. AU has contributed to the official Danish FP10 position which will come out later this autumn.

Take part in the public consultation on Erasmus+ evaluation

The Commission has launched a public consultation for the evaluation of the Erasmus+ programme. The consultation seeks input from citizens and organisations on the EU's flagship programme for education, training, youth and sport.

It aims to gather feedback on programme novelties, inclusion measures, simplification progress, and ideas for future development. This consultation is a crucial step in assessing the programme's overall performance based on five key criteria. The consultation is available until 8 December.
